Total Home Comfort Program Instant Discount Offer – Supplemental Terms and Conditions

In lieu of a project rebate paid to the customer from National Grid, Total Home Comfort Program Approved Partners may offer National Grid residential gas customers an instant discount amounting to the value of the estimated Total Home Comfort incentive at time of invoice payment. The customer's paid invoice shall clearly note the invoice sub-total before discount, instant discount applied to that invoice sub-total and attributed to "National Grid Total Home Comfort Program Instant Discount \$XXX.XX", and the final invoice total subtracting that discount value.

National Grid customers with firm fixed gas heating rate accounts in KEDLI and KEDNY operating company territories, participating in the Total Home Comfort Program, are eligible for instant discounts.

The provider applying the discount to the customer's project cost will be reimbursed for that discount value by electronic payment upon submittal of the customer's rebate application and rebate approval by National Grid. Providers should provide current IRS form W-9 and complete Leidos' automated clearing house request form to initiate electronic payment.

Providers must submit customer proposals offering the instant discount to the program administrator for pre-approval prior to signing a contract to do work with the customer. The pre-approval proposal must include the full project scope, completed measure savings calculator, and equipment specifications to allow verification of eligibility and incentive amounts. A pre-approval from the program administrator shall indicate that the estimated customer incentive value to be discounted from the invoice will be reimbursed in full given approval of an installed project that reflects the documented project specifications at time of pre-approval. If the installed project varies from the pre-approved project in scope or performance specifications that affect the expected energy savings, the value of the discount to be reimbursed will be revised to the installed project conditions.

Pre-approval of instant discounts is subject to availability of funds.
